When the school moved to more modern premises in 1969, it was sold to the church who still own the building.

In 2019 members of the community, concerned for its future, came together to form the charity **Lydgate Community Association**. Its main purpose is to preserve the Parish Hall to be the Community hub for future generations, and manage it so it serves the needs of this community and beyond.

Throughout its 152 years, many adults and children have passed through its doors. The LCA want to ensure that this continues. It is our heritage, which we cherish but it is also our future.
